Sub: - Competitive Examination for recruitment to the cadre of MTS from eligible GDS for the vacancy years 2018 (01.04.2018 to 31.12.2018), 2019 (01.01.2019 to 31.12.2019) and 2020(01.01.2020 to 31.12.2020) – Notification – reg.

The Competitive Examination limited to GDSs will be held on 2nd August 2020 (Sunday) for recruitment to the cadre of MTS for the vacancy years 2018 (01.04.2018 to 31.12.2018), 2019 (01.01.2019 to 31.12.2019) and 2020 (01.01.2020 to 31.12.2020). Accordingly, applications are invited from the willing and eligible candidates in the format enclosed (**Annexure-I**). The schedule of activities of the examination is furnished hereunder:

*Exam will commence exactly at 10:00 AM sharp and both Paper I & II will be conducted in continuity in one sitting from 1000 hrs to 1210 hrs. There will be 10 minute's break in between Paper-I and Paper-II, but candidates cannot be allowed to leave his/ her desk.

2. Vacancies: Recruiting Division/ Unit-wise vacancies for the years 2018 (01.04.2018 to 31.04.2018), 2019 (01.01.2019 to 31.12.2019) and 2020 (01.01.2020 to 31.12.2020) are attached as **Annexure-A**, **Annexure-B** and **Annexure-C** respectively.

3. Eligibility Criteria: As per the Department of Posts' MTS (Group 'C' post) Recruitment Rules, 2018 notified in GSR 781(E) dated 16.08.2018, and Department of Posts' MTS (Group 'C' post) Recruitment Rules, 2019 notified in GSR 850(E) dated 15.11.2019 (**Annexure-II**), the following categories of GDSs are eligible to appear in the examination:

Gramin Dak Sevaks (GDSs) who have worked regularly for three years in that capacity as on **01.04.2018 for the vacancy year 2018, 01.01.2019 for the vacancy year 2019 and 01.01.2020 for the vacancy year 2020.**

4. Educational Qualification:

No educational qualification is prescribed for Gramin Dak Sevak as per Para 2 Department of Posts MTS (Group 'C' post) Recruitment rules, 2019 notified in G.S.R 850(E) dated 15.11.2019.

5. **Age Limit:** There shall be no upper age limit for Gramin Dak Sevaks.

6. **Pattern & Syllabus of Examination:** The examination will be conducted as per the revised pattern and syllabus circulated by Directorate vide letter No. 17-08/2018-SPB-I dated 10.05.2019, under Annexure-'A' read with letter no. 17-08/2018-SPB-I dated 26.06.2019, 28.06.2019, 11.07.2019 and 23.07.2019. Details of pattern and syllabus are furnished as **Annexure III**.

7. **Centers of Examination:** The examination will be conducted at **Thiruvananthapuram, Kochi and Kozhikode**. The candidates will have to appear from the respective centers of their Circle only and under no circumstances, they be permitted to appear from centers of other Circles.

8. The application of the APS candidates should be sent to the concerned divisions only and not to Circle Office.

9. **Order of preferences for Recruiting Divisions:**

- (i) Candidate must submit his/her order of preference for the Recruiting Divisions/Units for consideration, in the Proforma at Annexure IV (A), Annexure IV (B) and Annexure IV (C) for the years 2018, 2019 & 2020 respectively.
- (ii) Candidate should submit the Proforma only for the years for which he/she is eligible to appear.
- (iii) Candidate to note that the list of Recruiting Divisions/Units includes his/her Parent Recruiting Division/Unit.
- (iv) If the Candidate does not want to be considered for selection to any of the Recruiting Divisions/Units, the Candidate shall write 'Not to be considered' against the Recruiting Divisions/Units accordingly.
- (v) Candidate should not leave any Row in the Proforma unfilled.
- (vi) The Divisional Heads should certify that the Candidate is eligible for the Vacancy year, the Proforma are filled properly and no Rows are left unfilled.
- (vii) **Order of Preferences once exercised is final and shall not be changed.**

9. The notification may be given wide publicity amongst all eligible candidates working in Divisions/Units.

सा.का.नि. 781(अ).—राष्ट्रपति, संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए और डाक विभाग (बहुकार्य कर्मचारिवृंद) भर्ती नियम, 2015, को उन बातों के सिवाय अधिकांत करते हुए जिन्हें ऐसे अधिक्रमण से पूर्व किया गया है, या करने का लोप किया गया है, डाक विभाग में बहुकार्य कर्मचारिवृंद के पद पर भर्ती की पद्धति के विनियमन हेतु निम्नलिखित नियम बनाते हैं, अर्थात् :-

1. संक्षिप्त नाम और प्रारंभ—

(i) इन नियमों का संक्षिप्त नाम डाक विभाग (बहुकार्य कर्मचारिवृंद) भर्ती नियम, 2018 है।

(ii) ये राजपत्र में प्रकाशन की तारीख से प्रवृत्त होंगे।

2. पदों की संख्या, वर्गीकरण और वेतन मैट्रिक्स में स्तर— पदों की संख्या, उनका वर्गीकरण, और वेतन मैट्रिक्स में स्तर वे होंगे जो इन नियमों से उपाबद्ध अनुसूची के स्तम्भ (2) से (4) में विनिर्दिष्ट हैं।

3. भर्ती की पद्धति, आयु सीमा, अर्हताएं, आदि— भर्ती की पद्धति, आयु सीमा, अर्हताएं और उक्त पद से संबंधित अन्य बातें वे होंगी, जो उक्त अनुसूची के स्तम्भ (5) से स्तम्भ (13) में विनिर्दिष्ट हैं।

4. निरर्हताएं— वह व्यक्ति,—

(क) जिसने ऐसे व्यक्ति से, जिसका पति या जिसकी पत्नी जीवित है, विवाह किया है; या

(ख) जिसने अपने पति या अपनी पत्नी के जीवित होते हुए किसी अन्य व्यक्ति से विवाह किया है,

उक्त पद पर नियुक्ति का पात्र नहीं होगा :

परन्तु यदि केन्द्रीय सरकार का यह समाधान हो जाता है कि ऐसा विवाह, ऐसे व्यक्ति और विवाह के अन्य पक्षकार को लागू स्वीय विधि के अधीन अनुज्ञेय है और ऐसा करने के लिए अन्य आधार हैं, तो वह किसी व्यक्ति को इस नियम के प्रवर्तन से छूट दे सकेगी।

5. सेना डाक सेवा में सेवा करने की अपेक्षा.— उक्त अनुसूची में विनिर्दिष्ट पदों पर नियुक्त कोई व्यक्ति अपेक्षानुसार भारत में या भारत से बाहर सेना डाक सेवा में सेवा करने का दायी होगा।

6. शिथिल करने की शक्ति.— जहां केन्द्रीय सरकार की यह राय है कि ऐसा करना आवश्यक या समीचीन है, वहां उसके लिए जो कारण हैं उन्हें लेखबद्ध करके, इन नियमों के किसी उपबंध को किसी वर्ग या प्रवर्ग के व्यक्तियों की बाबत, आदेश द्वारा शिथिल कर सकेगी।

7. व्यावृत्ति.— इन नियमों की कोई बात, ऐसे आरक्षणों और उन रियायतों पर प्रभाव नहीं डालेगी, जिनका केन्द्रीय सरकार द्वारा इस संबंध में समय-समय पर जारी किए गए आदेशों के अनुसार अनुसूचित जातियों, अनुसूचित जनजातियों, भूतपूर्व-सैनिकों, अन्य पिछड़े वर्गों, और अन्य विशेष प्रवर्ग के व्यक्तियों के लिए उपबंध करना अपेक्षित है।

NOTIFICATION

New Delhi, the 16th August, 2018

G.S.R. 781(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Department of Posts (Multi Tasking Staff) Recruitment Rules, 2015, except as respect to things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Multi Tasking Staff in the Department of Posts, namely:—

- Short title and commencement.**—(1) These rules may be called the Department of Posts (Multi Tasking Staff) Recruitment Rules, 2018.
(2) They shall come into force on the date of their publication in the Official Gazette.
- Number of posts, classification and Level in the Pay Matrix.**—The number of posts, their classification and the Level in the Pay Matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- Method of recruitment, age limit, qualifications, etc.**—The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the said Schedule.
- Disqualification.**—No person,—
(a) who has entered into or contracted a marriage with a person having a spouse living; or
(b) who, having spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

5. **Requirement to serve in the Army Postal Service.**— Any person appointed to the posts specified in the said Schedule shall be liable to serve in the Army Postal Service in India or abroad, as required.
6. **Power to relax.**— Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
7. **Saving.**— Nothing in these rules shall affect reservations and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, ex-servicemen, Other Backward Classes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
