At present, India can potentially deploy 4G in 8 spectrum frequency bands - 700 megahertz (Mhz) band, 800 Mhz band, 900 Mhz band, 2100 Mhz band, 2300 Mhz hand, 2500 Mhz hand and 2600 Mhz band. Every band comprises around 100 Mhz of frequencies. However, the signals become weak after a few kilometers and the same set of frequencies are roused by installing a mobile tower. India is divided in 22 telecom circles for the numose of division and allocation of airwave frequencies. Hence the 800 Mhz of frequencies are being reused across India on circle basis.

In the case of spectrum, signals cover more area in lower frequency bands i.e. in terms of numerical value. For example, mobile signals transmitted in 700 Mhz band will cover three times more area than signals transmitted in 2100 Mhz band.

When it comes to 5G, a high level panel set up under the Ministry of Telecom identified around 6000 Mhz of radiowaves

comes in two forms-intrinsic motivation and extrinsic motivation. Extrinsic motivation comes from outside. You score well in examination and win appreciation from your teachers. family members and neighbours etc. which encourages you to do still better, is an example of extrinsic motivation. 



radiowaves used in 4G.

The panel has spotted spectrum for 5G service across 11 bands of which 4 bandsgigahertz (Ghz), 24 Ghz and 28 Ghz band can be made immediately available for the service.

According to the 5G panel estimates 5.250 Mhz of spectrum can be made available for 5G services in higher frequency hands, 300 Mbz in 3.5 Ghz band and 405 Mhz out 5G in India by 2020 and also their efforts that a son was spectrum in sub- 1000 Mhz.

At present the government has identified 300 Mhz of frequency between 3300-3600 Mhz range for 5G services. As per propagation behaviour of waves. the 5G signals will cover much smaller areas but with very high speed.

The nature of 5G technology is very different from 4G technology. It can be related to an example of a water pipe where the speed of water coming out of a thick pipe is slower than water coming out of thinner pipe.

The 5G technology will need special types of smaller mobile tower or points to transmit signals compared to base stations being deployed for 4G. Even the base stations (RTS) for 4G are smaller compared to BTS deployed for 2G. The 5G connectivity is considered to be more reliant compared to 4G because it will be able to connect devices almost like a dedicated and manufacturing.

Surveillance & Response measures for new variant of SARS-CoV 2

Health Ministry has issued Standard Operating Procedure (SOP) for Epidemiological Surveillance and Response for a new variant of SARS- CoV 2 virus, which has been reported by the UK government to World Health Organization (V/HO). This variant is estimated by European Center for Disease Control (ECDC) to be more transmissible and affecting younger population. This variant is defined by a set of 17 changes or mutations. One of the most significant mutation is in the spike protein that the virus uses to bind to the human ACE2 receptor. firms. She said, the move comes following recommendations of the GST Council's Law Committee in this regard. Ms Sitharaman said, the GST laws passed by the Parliament and state legislatures provide that GST registration is liable to be can celled for those who have not filed 6 or more returns.

Commerce Minister Piyush Goyal has said that there is tremendous scope for Aus tralian investment into India as India has eased its FDI norms and opened up different sectors. Addressing the CII session on Enhancing India-Australia Bilateral Economic and Trade Relationship on 18 December, Mr Goval said that India has also opened up the Agri sector for greater investments in food processing and value addition. He also launched India-Australia Economic Strategy Report.

■ EPFO net subscribers rise 56% to 11.55 lakh in October

The provisional payroll data of EPFO released, reveals that EPFO has added 11.55 lakh net subscribers in the month of October this year. Despite the COVID-19 pandemic. EPEO has added around 39.33 lakh subscribers during the current financial year from April to October, 2020. The data published comprises of members who have joined during the month and whose contribution has been received by EPFO for the wage month. Year-on-year comparison shows that October, 2020 has reqistered a healthy 56 per cent growth in terms of net payroll addition as compared to not subscriber growth of 7.39 lakh registered during October last year, indicating robust recovery to pre Covid-19 levels. In October 2020, around 7.15 lakh new members have joined EPFO and approximately 2.40 lakh members exited Genderwise analysis shows that around 2.08 lakh net female subscribers were added during October 2020. Women contributed around 21 per cent of the new subscribers for October 2020.

Protests across Balochistan against killing of Karima Baloch in Canada

Protest raties were carried out in different cities across Balochistan against the killing of prominent leader and activist Karima Baloch in Canada. Hundreds of people including activists gathered in various places in Quetta and Hub City demanding a fair probe by the Canadian government into Karima's sudden death.



Karima, a vocal critic of the Pakistan Army and government atrocities in Balochis tan, was found dead in Toronto. The Baloch activist had arrived in Canada in 2016 and campaigned extensively against disappearances and human rights violations in the troubled Balochistan province
