(e) **TATTOO :-**

- On completion of detailed medical examination, if a candidate is declared Medically Unfit, he/she will be given an opportunity to appeal against the findings of the Medical board. He/she will be handed over documents enclosed as <u>Annexure 'F', 'F-1' & 'F-2'</u> by the medical board with direction to submit above documents duly completed in all respect within 15 days from the date of issue of the Memorandum.
